Corporate Membership Rules and Regulations:

As a corporate member, please familiarize yourself with the rules and regulations to ensure a fair, transparent, and mutually beneficial relationship between your organization and CROW. Here are some key rules and regulations associated with corporate membership.

As a corporate member, you will enjoy the specified benefits from the date of payment until the subsequent year, providing you with a full year of membership privileges:

- Bronze, Silver, and Gold sponsors will receive one acknowledgment announcement on CROW's Facebook and Instagram pages per annum.
- Platinum and Diamond sponsors will receive two featured posts on CROW's Facebook and Instagram pages per annum.
- Gold, Platinum and Diamond sponsors receive one advertising space per annum in our newsletter. Design work to be supplied by sponsor, according to specifications provided by CROW.
- Diamond sponsors may enjoy one private tour of CROW's facilities per annum with a maximum limit of 10 individuals. To schedule the tour, it must be booked at least one month in advance, on a date decided by both parties.
- Diamond sponsors will enjoy exclusive access to CROW's Education Centre, designed to accommodate a maximum of 60 individuals. Reservations must be made at least one month in advance and are subject to availability within CROW's working hours. Any catering requirements will need to be provided by sponsors.
- Members are not entitled to refunds for amounts withdrawn under this authority while they were valid, provided such amounts were legally owed.
- Members should disclose and manage any potential conflicts of interest. It is important to avoid situations where business interests may compromise CROW's integrity or independence.
- When publicising our collaboration, it is important that it accurately represents CROW's work and mission. In order to avoid any misleading statements that could harm the organization's reputation, we would request that CROW is afforded the opportunity to check any press releases or announcements for accuracy.
- Confidentiality of any sensitive information shared by CROW must be respected. The privacy of individuals served by the organization must be protected, and sponsors should refrain from disclosing confidential data without proper authorization.
- Open lines of communication with CROW's leadership should be maintained, collaborating in a spirit of partnership, and respecting CROW's autonomy and decision-making processes.
- Companies can claim deductions for donations made to CROW under Section 18A of the Income Tax Act. Companies who have offered financial support or in-kind donations can claim this benefit by requesting Section 18A certificates, which CROW issues upon request.
